G. High School Student Tuition Reduction Program

The proposed High School Tuition Reduction Program would reduce tuition by 1/3rd for students from identified "cohort" programs within our feeder high school districts 205, 215, and 228. This should encourage students to enroll in additional classes and thereby strengthen the College's relationship with our district high school students.
