The regular monthly meeting of the Board of Trustees of South Suburban College, Illinois Community College District No. 510 was held at South Suburban College, 15800 S. State Street, South Holland, II. on June 12, 2008, in the Board Room of the College.

The possible benefit to the College is \$43,973,366 from the State. This would require a 25% match from the College of \$12,457,789.
